#### You are about to purchase a product that is not simple and may be difficult to understand.

## What is this product?

Туре	The product is in the form of a note issued under German law. It is an interest bearing security.
Term	The product has a fixed term and will be due on May 21, 2025.
Objectives	The product pays a fixed rate of interest. What you will receive at the end of the term of the product is not certain and will depend on the performance of the ordinary shares of Suedzucker AG (ISIN: DE0007297004), listed on XETRA (the <b>underlying asset</b> ). However, you will take the risk that some or all of the value of your investment may be lost at the end of the term of the product. The product has a fixed term, ending on May 21, 2025. Each note has a face value of EUR 1,000. The issue price is 100.17% of the face value. The product will be listed on both Munich Stock Exchange and Boerse Stuttgart (Open Market (EUWAX)). The issue date is April 29, 2024.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a low level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

In the case of the delivery of underlying asset, losses may arise after May 16, 2025 until the underlying asset is transferred to your securities account.

This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

# What happens if Goldman Sachs Bank Europe SE is unable to pay out?

You are exposed to the risk that the Issuer might be unable to fulfil its obligations in respect of the product – e.g. in the event of insolvency (inability to pay / over-indebtedness) or an administrative order of resolution measures. # How long should I hold it and can I take money out early?

#### Recommended holding period: 2 weeks and 2 days

The recommended holding period for the product is 2 weeks and 2 days as the product is designed to be held until maturity; however the product may terminate early due to an extraordinary event. You have no contractual right to terminate the product prior to maturity.

The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-by-case basis. In addition the product is expected to be listed on Munich Stock Exchange and Boerse Stuttgart (Open Market (EUWAX)), which may provide you the possibility to sell the product prior to maturity via these exchanges. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product. In addition, the person who sold you the product may charge you brokerage fees when you sell the product.
