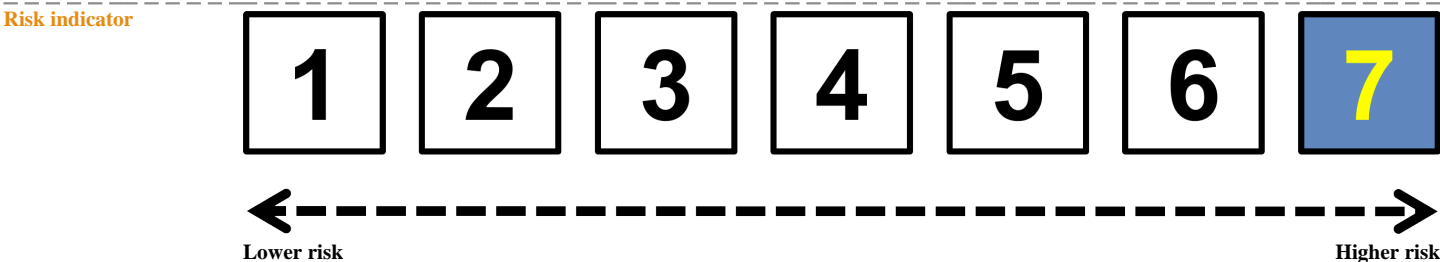
**You are about to purchase a product that is not simple and may be difficult to understand.**

## What is this product?

Type	The product is in the form of a warrant issued under German law. It is not an interest bearing security.
Term	The product has a fixed term and will be due on January 21, 2026.
Objectives	<p>The product provides the potential for capital growth and does not pay interest. What you will receive at the end of the term of the product is not certain and will depend on the performance of the ordinary shares of Nvidia Corporation (ISIN: US67066G1040), listed on the NASDAQ Global Select Market (the <b>underlying asset</b>). You will take the risk that some or all of the value of your investment may be lost upon termination of the product. The product has a variable term that depends on whether and when you exercise the product. However, the term of the product will end no later than on January 21, 2026. The price of each warrant is scaled by a factor of 1, representing the exposure to the underlying asset. The issue price is EUR 11.48. The product will be listed on both the Munich Stock Exchange and the Boerse Stuttgart (Open Market (EUWAX)). The issue date is June 5, 2024.</p> <p><b>Repayment at maturity:</b></p> <p>For each warrant that you hold there are two scenarios:</p> <ol style="list-style-type: none"> <li>If the closing price of the underlying asset on the valuation date is above USD 185, you will on the maturity date receive a cash amount equal to the closing price of the underlying asset on the valuation date minus USD 185. The result will be multiplied by 1 and will be converted into EUR using the WM Company LDN 4pm Mid exchange rate on the valuation date; or</li> <li><i>Otherwise</i>, you will receive no payment and you will lose your entire investment.</li> </ol> <p>If you exercise the product, the valuation date will be the day on which you exercise the product and the maturity date will be the date falling 3 business days following this date. ## What are the risks and what could I get in return?





The risk indicator assumes you keep the product until January 21, 2026.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a very high level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

#### What happens if Goldman Sachs Bank Europe SE is unable to pay out?

You are exposed to the risk that the Issuer might be unable to fulfil its obligations in respect of the product – e.g. in the event of insolvency (inability to pay / over-indebtedness) or an administrative order of resolution measures. In case of a crisis of the Issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. ## How long should I hold it and can I take money out early?

### ***Recommended holding period: 8 months and 3 weeks***

The recommended holding period for the product is 8 months and 3 weeks as the product is designed to be held until maturity; however the product may terminate early due to an extraordinary event. You have no contractual right to terminate the product prior to maturity.

The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-by-case basis. In addition the product is expected to be listed on Munich Stock Exchange and Boerse Stuttgart (Open Market (EUWAX)), which may provide you the possibility to sell the product prior to maturity via these exchanges. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product. In addition, the person who sold you the product may charge you brokerage fees when you sell the product.
