You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The product is in the form of a note issued under German law. It is an interest bearing security.

Term **Objectives** The product has a fixed term and will be due on June 25, 2025.

The product pays a fixed rate of interest. What you will receive at the end of the term of the product is not certain and will depend on the performance of the preference shares of Porsche Automobil Holding SE (ISIN: DE000PAH0038), listed on XETRA (the underlying asset). However, you will take the risk that some or all of the value of your investment may be lost at the end of the term of the product. The product has a fixed term, ending on June 25, 2025. Each note has a face value of EUR 1,000. The issue price is 98.60% of the face value. The product will be listed on both Munich Stock Exchange and Boerse Stuttgart (Open Market (EUWAX)). The issue date is July 24, 2024.

Interest: At maturity, you will receive interest of EUR 165.481698 for each note that you hold.

Redemption at maturity:

On June 25, 2025, for each note that you hold:

- If the closing price of the underlying asset on June 20, 2025 is at least equal to the strike price, you will receive EUR 1,000.00; or
- Otherwise, you will receive 20 shares of the underlying asset plus the cash equivalent of 0.8333 shares. In this case, you will receive assets worth less than EUR 1,000. The value of these assets will reflect the negative performance of the


The initial reference price is EUR 42.86, which is the closing price of the underlying asset on July 17, 2024. The strike price is EUR 48, which is 111.9925338311% of the initial reference price.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying asset, the product and the product manufacturer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

Intended retail investor The product is intended to be offered to retail investors who:

- have the ability to make an informed investment decision through sufficient knowledge and understanding of the product and its specific risks and rewards, with experience of investing in and/or holding a number of similar products providing a similar market exposure;
- seek income, expect the movement in the underlying asset to perform in a way that generates a favourable return and have an investment horizon of the recommended holding period specified below;
- accept the risk that the issuer could fail to pay or perform its obligations under the product but otherwise are able to bear a total loss of their investment; and
- are willing to accept a level of risk to achieve potential returns that is consistent with the summary risk indicator shown below.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product until June 25, 2025.



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 1 out of 7, which is the lowest risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a very low level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

In the case of the delivery of underlying asset, losses may arise after June 20, 2025 until the underlying asset is transferred to your securities account.

This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

The favourable, moderate, unfavourable and stress scenarios represent possible outcomes that have been calculated based on simulations using the past performance of the underlying asset over a period of up to 5 years. What happens if Goldman Sachs Bank Europe SE is unable to pay out?

You are exposed to the risk that the Issuer might be unable to fulfil its obligations in respect of the product – e.g. in the event of insolvency (inability to pay / over-indebtedness) or an administrative order of resolution measures. In case of a crisis of the Issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. How long should I hold it and can I take money out early?

Recommended holding period: 6 days

The recommended holding period for the product is 6 days as the product is designed to be held until maturity; however the product may terminate early due to an extraordinary event. You have no contractual right to terminate the product prior to maturity.

The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-by-case basis. In addition the product is expected to be listed on Munich Stock Exchange and Boerse Stuttgart (Open Market (EUWAX)), which may provide you the possibility to sell the product prior to maturity via these exchanges. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product. In addition, the person who sold you the product may charge you brokerage fees when you sell the product.
