You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

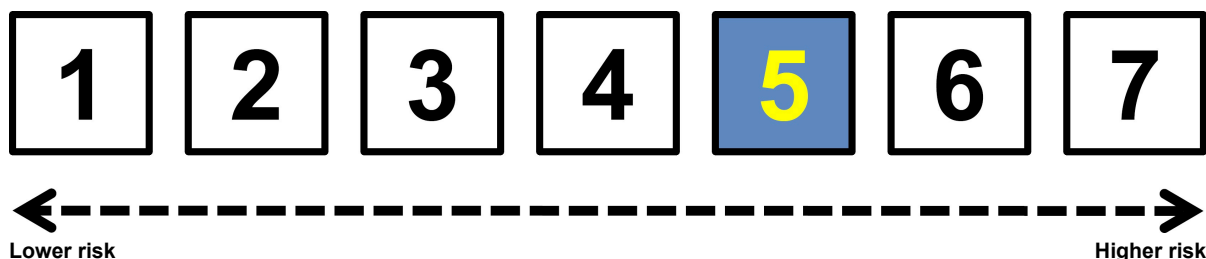
Type	The product is in the form of a note issued under German law. It is an interest bearing security.
Term	The product has a fixed term and will be due on February 25, 2026.
Objectives	<p>The product pays a fixed rate of interest. What you will receive at the end of the term of the product is not certain and will depend on the performance of the ordinary shares of BASF SE (ISIN: DE000BASF111), listed on XETRA (the underlying asset). However, you will take the risk that some or all of the value of your investment may be lost at the end of the term of the product. The product has a fixed term, ending on February 25, 2026. Each note has a face value of EUR 1,000. The issue price is 94.10% of the face value. The product will be listed on Boerse Frankfurt Zertifikate (Open Market), Munich Stock Exchange, Boerse Stuttgart (Open Market) and Boerse Stuttgart (Open Market (EUWAX)). Intended retail investor The product is intended to be offered to retail investors who:

- have the ability to make an informed investment decision through sufficient knowledge and understanding of the product and its specific risks and rewards, with experience of investing in and/or holding a number of similar products providing a similar market exposure;
- seek income, expect the movement in the underlying asset to perform in a way that generates a favourable return and have an investment horizon of the recommended holding period specified below;
- accept the risk that the issuer could fail to pay or perform its obligations under the product but otherwise are able to bear a total loss of their investment; and
- are willing to accept a level of risk to achieve potential returns that is consistent with the summary risk indicator shown below.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product until February 25, 2026.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a medium-high level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

In the case of the delivery of underlying asset, losses may arise after February 20, 2026 until the underlying asset is transferred to your securities account.

This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

The favourable, moderate, unfavourable and stress scenarios represent possible outcomes that have been calculated based on simulations using the past performance of the underlying asset over a period of up to 5 years. The stress scenario shows what you might get back in extreme market circumstances.

What happens if Goldman Sachs Bank Europe SE is unable to pay out?

You are exposed to the risk that the Issuer might be unable to fulfil its obligations in respect of the product – e.g. in the event of insolvency (inability to pay / over-indebtedness) or an administrative order of resolution measures. In case of a crisis of the Issuer such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. How long should I hold it and can I take money out early?**Recommended holding period: 9 months and 2 weeks**

The recommended holding period for the product is 9 months and 2 weeks as the product is designed to be held until maturity; however the product may terminate early due to an extraordinary event. You have no contractual right to terminate the product prior to maturity.

The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-by-case basis. In addition the product is expected to be listed on Boerse Frankfurt Zertifikate (Open Market), Munich Stock Exchange, Boerse Stuttgart (Open Market) and Boerse Stuttgart (Open Market (EUWAX)), which may provide you the possibility to sell the product prior to maturity via these exchanges. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product.
