Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

The product is in the form of a certificate issued under English law. It is an interest bearing security. The payment obligations of the product manufacturer are not guaranteed by any entity.

Term

The product has a fixed term and will be due on March 16, 2026, subject to an early redemption.

Objectives

The product pays a fixed rate of interest. What you will receive at the end of the term of the product is not certain and will depend on the performance of the ordinary shares of Farfetch Limited (ISIN: KY30744W1070), Moncler S.p.A (ISIN: IT0004965148) and Kering S.A. (ISIN: FR0000121485), listed on New York Stock Exchange, Borsa Italiana and Euronext Paris S.A., respectively (the **underlying assets**). However, you will take the risk that some or all of the value of your investment may be lost at the end of the term of the product. The term of the product will end no later than March 16, 2026. However, we have the right to terminate the product early. Each certificate has a face value of EUR 100. The issue price is EUR 100. The product will be listed on Borsa Italiana (SeDeX). The issue date is March 8, 2023.

Interest: On each interest payment date, you will receive interest of EUR 1.10 for each certificate that you hold. Interest payment dates are dates falling 5 business days after each interest reference date. Interest reference dates are each trading day rolling monthly from April 8, 2023 (inclusive) to March 8, 2026 (inclusive).

Call feature: We have the right to terminate the product early on each call payment date upon 5 business days notice, being the corresponding call dates. In this case you will receive EUR 100.00 in addition to the interest payable on or around such date for each certificate that you hold. Call dates are each trading day rolling monthly from September 8, 2023 (inclusive) to February 8, 2026 (inclusive).

Repayment at maturity:

This section applies only if we do not terminate the product early as described above.

On March 16, 2026, for each certificate that you hold:

- If the closing price of the underlying asset with the lowest performance (as compared with its initial reference price) on March 9, 2026 is at least equal to its barrier price, you will receive EUR 100.00; or
- Otherwise, you will receive EUR 100.00 multiplied by (i) the closing price of the underlying asset with the lowest performance (as compared with its initial reference price) on March 9, 2026 divided by (ii) the strike price of such underlying asset.

The strike prices, barrier prices and initial reference prices are shown below.

The initial reference price of an underlying asset is the closing price of such underlying asset on March 8, 2023.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying assets, the product and the product manufacturer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

The risk indicator assumes you keep the product until March 16, 2026.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a medium-low level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

How long should I hold it and can I take money out early?

Recommended holding period: 2 years and 2 months

The recommended holding period for the product is 2 years and 2 months as the product is designed to be held until maturity; however the product may terminate early due to an issuer call or an extraordinary event. You have no contractual right to terminate the product prior to maturity.

The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-by-case basis. In addition the product is expected to be listed on Borsa Italiana (SeDeX), which may provide you the possibility to sell the product prior to maturity via this exchange. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product. In addition, the person who sold you the product may charge you brokerage fees when you sell the product.
