This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type The product is in the form of a warrant issued under German law. It is not an interest bearing security. The payment obligations of the product manufacturer are guaranteed by The Goldman Sachs Group, Inc. (the "**Guarantor**").

Term The product does not have a fixed term, subject to exercise by the investor or termination by the manufacturer.

Objectives The product provides the potential for capital growth and does not pay interest. What you will receive at the end of the term of the product is not certain and will depend on the performance of the ICE Brent Crude Oil Future expiring in August 2025 (the **underlying asset**). The underlying asset will be rolled each month to the futures contract expiring in the immediately proceeding month. The roll date shall be 10 trading days prior to the expiry date of the underlying asset. The payment you will receive on exercise by you or termination by the manufacturer increases disproportionately as the underlying asset performs negatively, but you also bear a greater risk of loss if the underlying performs positively. In addition, you will take the risk that some or all of the value of your investment may be lost upon termination of the product. The product has a variable term that depends on the performance of the underlying asset and on whether and when you exercise the product or the manufacturer terminate the product. The price of each warrant is scaled by a factor of 1, representing the exposure to the underlying asset. The issue price is EUR 5.87. The product will be listed on the Euronext Access Paris. The issue date is May 14, 2025.

Automatic termination:

If the trading price of the underlying asset at any time on any trading day during the term of the product is at or above the current knock-out barrier (being USD 66.65206 as of June 6, 2025), the product will terminate immediately. The cash amount you will receive will be calculated as the current strike (being USD 68.69628 as of June 6, 2025) minus a price of the underlying asset determined by the manufacturer in the 3 trading hours following the occurrence of such event. The result will be multiplied by 1 and can be zero. The cash amount will be converted into EUR using the WM Company LDN 4pm Mid exchange rate on the valuation date.

Exercise by you or termination by the manufacturer:

This section applies only if no automatic termination occurs as described above.

You may exercise the product on any Frankfurt business day during the term of the product. Conversely, the manufacturer may terminate the product on any business day during the term of the product. In each case the cash amount you will receive will be equal to the current strike minus the fixing price of the underlying asset on the valuation date. The result will be multiplied by 1. The cash amount will be converted into EUR using the WM Company LDN 4pm Mid exchange rate on the valuation date. The valuation date will be the day on which you validly exercise the product or the day on which our termination notice to you becomes effective.

As of June 6, 2025, the current strike is USD 68.69628 and the current knock-out barrier is USD 66.65206. The manufacturer adjust the current strike daily to reflect fees and the cost of rolling the underlying asset, which will tend to reduce the value of the product. The manufacturer may also adjust the current knock-out barrier periodically to reflect changes in the current strike. You should therefore ensure you check for changes to both the current strike and the current knock-out barrier regularly.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying asset, the product and the product manufacturer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

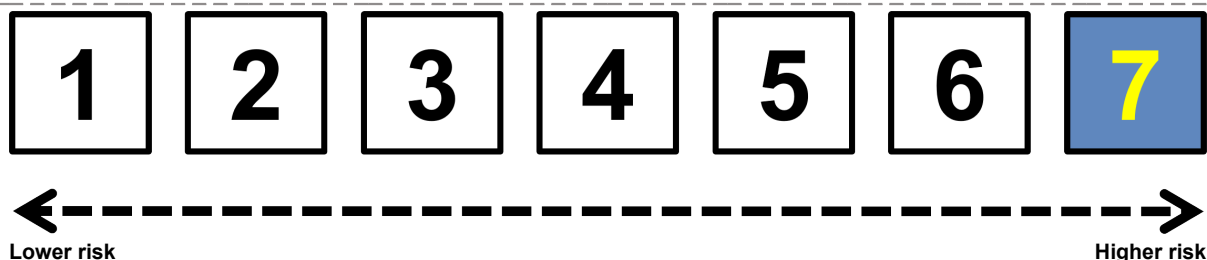
Intended retail investor The product is intended to be offered to retail investors who:

1. have advanced knowledge and a comprehensive understanding of the product, its market and its specific risks and rewards, with relevant financial industry experience including either frequent trading or large holdings in products of a similar nature, risk and complexity;
2. seek capital growth, hedging and/or leveraged performance, expect the movement in the underlying asset to perform in a way that generates a favourable return, have an investment horizon of the recommended holding period specified below and understand that the product may terminate early;
3. accept the risk that the issuer or guarantor could fail to pay or perform its obligations under the product but otherwise are able to bear a total loss of their investment; and

4. are willing to accept a level of risk to achieve potential returns that is consistent with the summary risk indicator shown below.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 1 day. The actual risk can vary significantly if you cash in at a later stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a very high level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

We may adjust the current strike and the current knock-out barrier, and may terminate the product at any time. Either action may have a negative impact on your return.

This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

Inflation erodes the purchasing value of cash over time and this may result in the decline in real terms of any capital reimbursed.

Performance scenarios What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

How long should I hold it and can I take money out early?

Recommended holding period: 1 day

The recommended holding period for the product is 1 day; however the product may terminate early due to an automatic termination or an extraordinary event.

The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-by-case basis. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product.
