This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type	The product is in the form of a certificate issued under English law. It is an interest bearing security, but your interest is not guaranteed. The payment obligations of the product manufacturer are not guaranteed by any entity.
Term	The product has a fixed term and will be due on June 17, 2024, subject to an early redemption.
Objectives	<p>The product pays interest that is linked to the performance of the underlying asset (as defined below). What you will receive at the end of the term of the product is not certain and will depend on the performance of the ordinary shares of Air France-KLM S.A. (ISIN: FR001400J770), listed on Euronext Paris S.A. (the underlying asset). In addition, you will take the risk that some or all of the value of your investment may be lost at the end of the term of the product. The term of the product will end no later than June 17, 2024. However, the product may terminate early depending on the performance of the underlying asset. Each certificate has a face value of EUR 100. The issue price is EUR 100. The product will be listed on Borsa Italiana (SeDeX). The issue date is June 9, 2020.</p> <p>Interest: If the closing price of the underlying asset on an interest observation date is at or above the interest barrier, you will receive interest of EUR 1.00 on the corresponding interest payment date for each certificate that you hold. In this case, you will also receive EUR 1.00 for each previous interest payment date where no interest has been payable. Interest observation dates are each trading day rolling monthly from July 9, 2020 (inclusive) to June 9, 2024 (inclusive). These events are specified in the product terms and principally relate to the underlying asset, the product and the product manufacturer. 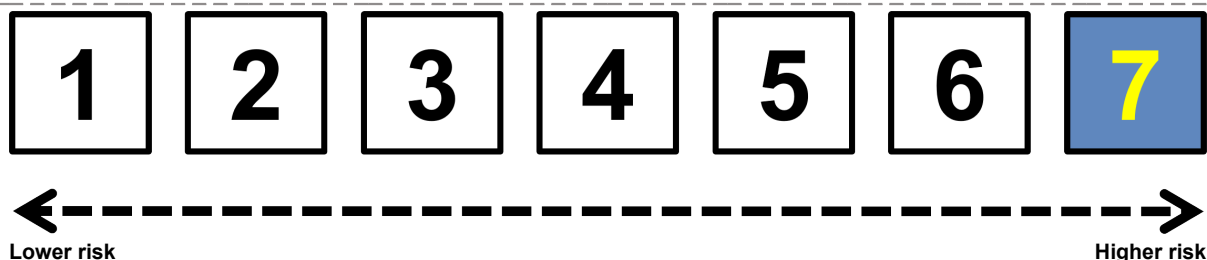
Intended retail investor The product is intended to be offered to retail investors who:

- have advanced knowledge and a comprehensive understanding of the product, its market and its specific risks and rewards, with relevant financial industry experience including either frequent trading or large holdings in products of a similar nature, risk and complexity;
- seek capital growth, expect the movement in the underlying asset to perform in a way that generates a favourable return, have an investment horizon of the recommended holding period specified below and understand that the product may terminate early;

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product until June 17, 2024.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a very high level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

How long should I hold it and can I take money out early?

Recommended holding period: 1 month and 2 weeks

The recommended holding period for the product is 1 month and 2 weeks as the product is designed to be held until maturity; however the product may terminate early due to an autocall or an extraordinary event. You have no contractual right to terminate the product prior to maturity.

The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-by-case basis. In addition the product is expected to be listed on Borsa Italiana (SeDeX), which may provide you the possibility to sell the product prior to maturity via this exchange. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product. In addition, the person who sold you the product may charge you brokerage fees when you sell the product.
